Policy for Plagiarism

The outcome of research is reflected in the publication of research articles in reputed peer reviewed journals. However, the integrity is a mute question in case of the reports, M.Sc., M.Phil. and Ph.D. thesis produced from our College. To uphold academic integrity and curb plagiarism in Research, the College has procured best plagiarism detection tool, during the year 2018 and developed the policy for plagiarism.

Any project report and publication other than peer reviewed journal should undergo rigorous check before submission. The supervisor need to send the final draft for plagiarism check to the library and the upper limit is 15% for PG projects and 8-10% for M. Phil. and Ph.D. Thesis. A student is given 3 free chances to attain the above. Failure of this, need to re do the full procedure on payment basis, which is solely decided by the Research Committee. A candidate's project/thesis is accepted by the HoD for evaluation, only with the certificate of Plagiarism. After the evaluation/completion of viva-voce, their final thesis should be deposited in the repository in order to prevent duplication in the following years.

Outcome of the plagiarism in Research: The publication would be of high quality and also avoids duplication or replication of any work. The integrity and ethics would reflect in the area of research and also the etiquette of College would be retained.

CIRCULAR

Sub: Fixing of Plagiarism Permissible Limit and Removal of Self Plagiarism -
reg.

Ref: C. No. PU / R2 / 105th Syn / 0029 / 2019-6, Dated: 01/11/2019.

As per the UGC regulations, the University has set up a mechanism for preventing plagiarism and ensuring that documents such as thesis, dissertation, publications or any other documents are free of plagiarism at the time of their submission to the University.

Presently the university accepts the permissible plagiarism limit up to 30%. Here after the acceptable limit of plagiarism is upto 20% only. If the percentage of plagiarism is above 20% the researcher has to modify and resubmit the thesis or document again for checking plagiarism.
